- 6** Owners or handlers are requested to provide adequate restraint apparatus, and to be present at all times during the animal's treatment session.
- 7** Moorfield Equine Massage reserves the right to retain video footage and photographs, taken during treatment sessions, for records and referrals. These will not be used elsewhere without the owner's permission.
- 8** Moorfield Equine Massage does not take any responsibility whatsoever for an accident/injury sustained either by practitioners or the animal's handler, whilst the animal is undergoing massage treatment.
